2025 Highlights

- **42 Home Repairs Completed:** Ensuring Veterans, Disabled and Seniors can age in place by performing critical repair needs.


Financial Success:

Over \$500,000 Raised: Contributions included donations, grants, special events, and in-kind donations.


- Our **Annual Golf Tournament** was the largest to date, raising over \$50,000.
- Our **Women Build** raised almost \$18,000
- **Lennar Home Builders** partnered with us to build 4 homes at cost on Tiffany Lane
- **Parrish Construction**: Sponsored our Perry Build as part of their 30 Year Anniversary Celebration
- **Publix Super Market Charities**: Sponsored a Veterans Build Home, enabling a local veteran's family to achieve homeownership.
- **Habitat ReStore**: Generated another year of record-breaking sales of over a \$900,000 in sales, covering operational costs and contributing \$125,000 toward home construction.

Other Achievements:

- Partnered with local developers and builders to expand our home-building capacity.
- Updated the Repair Corps Program and New Homeowner application online to make it easier to apply.
- Hired additional ReStore staff to expand operations.
- Remodeled the ReStore to provide a better shopping experience for customers and more efficient operations.


